
Investment mandate and objective

The fund is multi-managed to add diversification of investment strategies and sources of returns. The managers use various capital protection strategies to deliver consistent, positive returns within a low to moderate risk parameter. The managers have various investment styles, ranging from asset allocation to stock selection and multiple asset class exposures all of which are designed to lower market risk and increase returns.






Asset class exposure (%)
