Investment mandate and objectives

The primary investment objective of the Fund is to generate real positive returns over time through the active management of a combination of money market, bond and income generating instruments. The strategy and investment mandate of the fund has a focus on income generation, with downside protection of capital.

Features: The fund will primarily invest in a range of fixed income securities including instruments guaranteed by the Republic of South Africa, gilts, semi-gilts, loan stock, preference shares, debentures, debenture stock, debenture bonds, unsecured notes, financially sound listed property investments, participatory interest in collective investment schemes and any other instruments guaranteed by the Republic of South Africa which are considered consistent with the fund's primary objective. Taquanta Asset Management is our preferred investment manager mandated to achieve the above investment objectives.

Quarterly commentary

Government bonds have enjoyed another good quarter, as the real yields offered are still attractive to more cautious investors and those still wary of relatively high-priced equities. The South African bond index rose 13.5%. There were two additional rate cuts by the South Africa Reserve Bank with the Repo rate ending at 3.75% down from 5.25% at the start of the quarter. It is hoped that this rate reduction will ease the interest burden on consumers and assist in stabilising the economy as the lockdown restrictions are eased. Many businesses are likely to experience difficult trading conditions as personal spending patterns have changed dramatically.

The South African GDP shrank by an annualised rate of -2% in the first quarter (better than the forecast of a 3.8% decline). Realistically the economy was not in good shape prior to the Covid-19 lockdown. Forecasts for GDP in 2020 are for a negative growth of -8%.

More alarming was Tito Mboweni's Supplementary Budget Review which forecast concerning numbers of a projected 81.8% debt to GDP ratio for this year growing to 87.4% by 2023/24. This might lead to a further ratings downgrade and hence a higher rate of interest which South Africa will have to pay on an ever-increasing debt burden. Not good news for consumers and taxpayers. The Rand took a sharp fall during the quarter to trade as low as R19/\$ but fared reasonably well by quarter end strengthening by 2.8% to R17.35/\$.

Mandate compliance

The fund remains within the reporting regime as at the date of this report.

Dealing prices are calculated on a net asset value and auditor's fees, bank charges and trustee fees are levied against the portfolios. Performance is calculated for the portfolio, as well as that the individual investor performance may differ as a result of initial fees, the actual investment date, the date of reinvestment and dividend withholding tax. Recurring investment or lump sum investment performances are quoted. Income distributions are included in the calculations. Performance numbers and graphs are sourced from GTC. NAV to NAV figures have been used. The investment performance is for illustrative purposes only. The investment performance is calculated after taking the actual initial fees and all ongoing fees into account. The reinvestment of income is calculated on the actual amount distributed per participatory interest by using the ex-dividend date NAV price of the applicable class of the portfolio, irrespective of the actual reinvestment date. No performance fees are charged on the GTC Fixed Income Fund. The GTC Fixed Income Fund Class B charges an annual service fee of 0.64% (excluding VAT).

The Risk profile of the portfolios ranges from low risk to high risk with a low risk portfolio potentially associated with lower rewards and a high risk portfolio with potentially higher rewards. This portfolio has a low risk profile. It is suitable for low to medium term investment horizons. It has an exposure to a combination of money market, bonds and income generating instruments. Where the asset allocation contained in this MDD reflects offshore exposure, the portfolio may be exposed to the following risks: potential constraints liquidity and the repatriation of funds; macroeconomic risks; political risks; foreign exchange risks; tax risks; settlement risks and potential limitations on the availability of market information. Definition of the terms used to measure the risk in the portfolios a) Tracking Error: tracking error or active risk is a measure of the risk in an investment portfolio that is due to active management decisions made by the portfolio manager; it indicates how closely a portfolio follows the index to which it is benchmarked and b) Standard deviation: is a measure that is used to quantify the amount of variation or dispersion of a set of data values around the mean value. This measure is commonly known as volatility and referenced as an explicit measure of risk. One can also obtain additional information on GTC products on the website and all price related queries or information is readily available on request. Fund of funds are portfolios that invests in portfolios of collective investment schemes that levy their own charges, which could result in a higher fee structure for the fund of funds. The daily cut off time is 14:00 for trades and the valuation point is 17:00. Prices are published on Finswitch by 10:00 daily. GTC Management Company (RF) (Pty) Ltd is registered as a Collective Investment Scheme Manager in terms of Section 5 of the Collective Investment Schemes Control Act and is a member of ASISA.
