The fund is Regulation 28 compliant and aims to outperform inflation plus 3% over rolling 5 year periods. 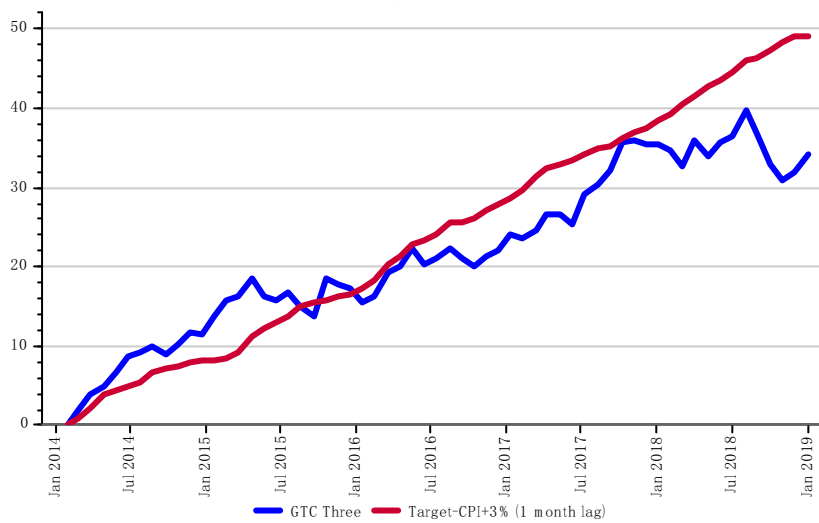

5 year cumulative performance history (%)



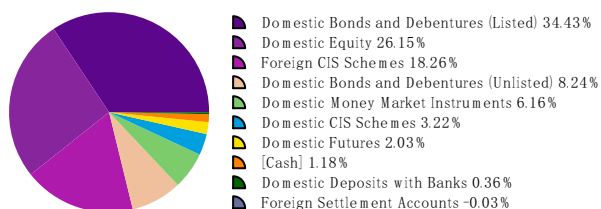

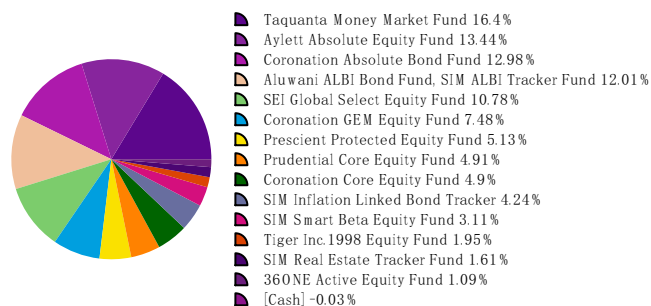

Asset class exposure



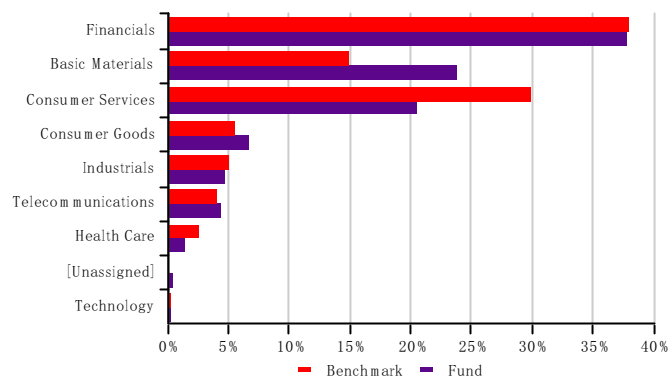
Investment manager weighting
