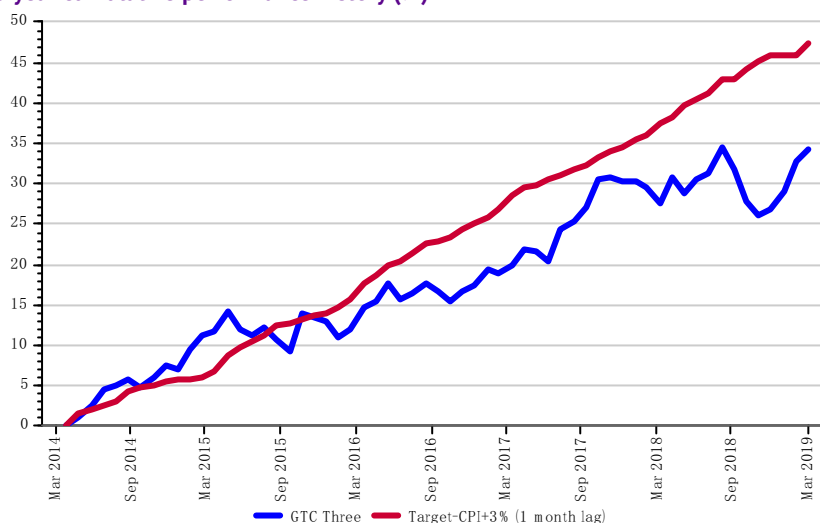

## 5 year cumulative performance history (%)



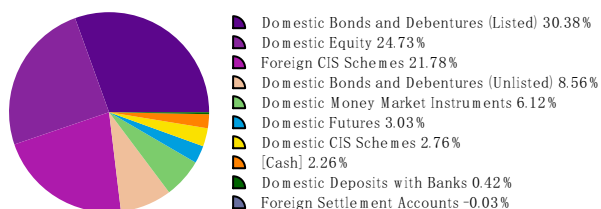

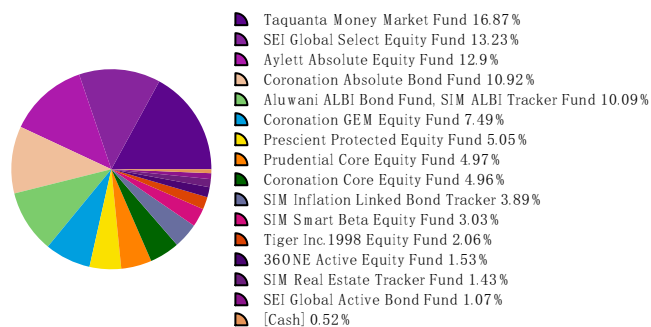

## Asset class exposure



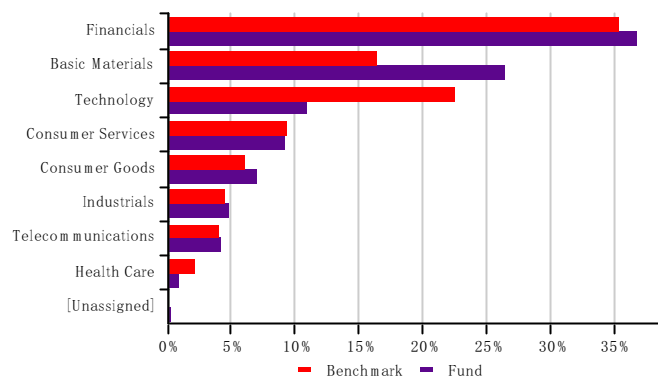
