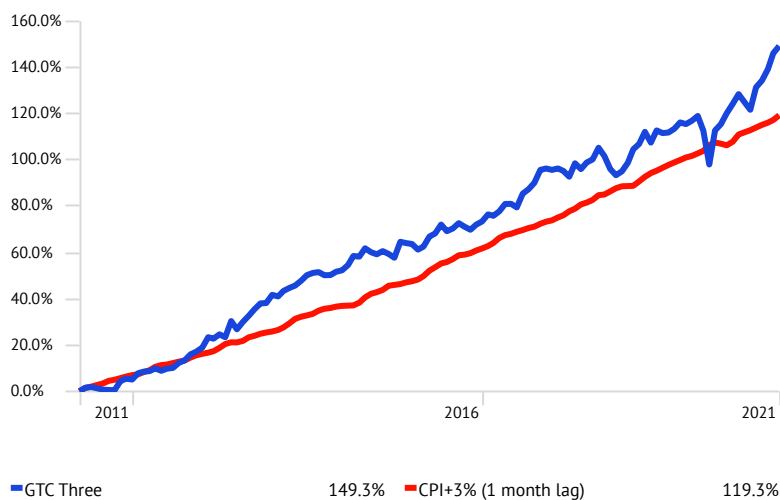
Investment mandate and objectives

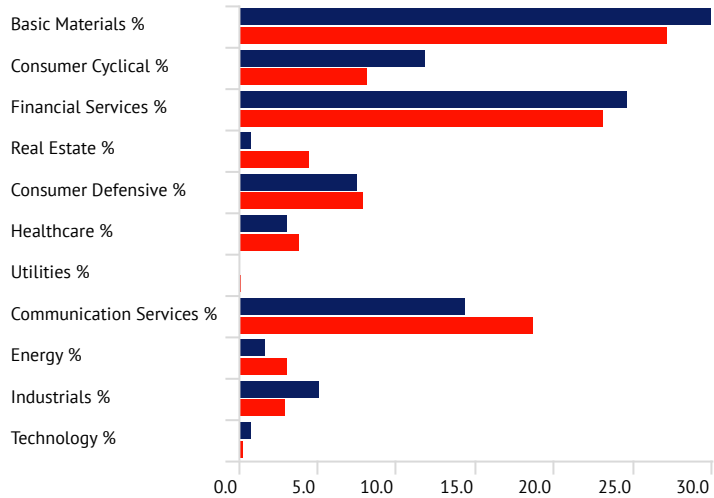
